# 5. COMMUNICATION FROM THE PUBLIC

Neal Hinson – Lincoln Crossing parent, and is a U2 pilot at Beal Air Force Base. He spoke on behalf of the overflow at Lincoln Crossing. He shared, his family had purchased a home in November of 2006, and his children attended Lincoln Crossing from 2006-2011. He then was transferred and had to move his family. He sense has moved back into his existing home and currently on the waiting list at Lincoln Crossing. He feels like he is being penalized for being in the military, with not being able to enroll his children back into Lincoln Crossing Elementary. He would like to see some consideration allowed for military families, and request the board take consideration.

Mr. Leaman recommended looking into the current policy. There was some discussion of reviewing the policy due to the waiting list. The board recommended allowing to be put at the top of the waiting list to enter Lincoln Crossing due to special circumstances. Mr. Leaman will bring back board policy to come back on August 19<sup>th</sup> for approval.

- 6.3 Western Placer Classified Employee Association Mike Kimbrough read the following:

I wanted to take the time tonight to let the School Board and Superintendent know the feedback I am getting from our classified members about the recent raises that were given to some District employees. I was going to wait, as school is not back in yet and I will be hearing from more of our members, but many have already contacted me and expressed their feelings, so I will bring it to you now. They are not very happy to the fact that a small group of employees received raises when all of classified employees working 4 hours or more are taking home less pay than they were in 2009 and also taking home less pay this year than last year when we had furlough days. This is also true of other groups.

In 2009, the district conducted a comparison and analysis of salaries. This comparison was brought to the school board in April of 2009. Classified employees ended up receiving a 3% raise. The Superintendent received a 6.5% raise, which was said to bring him up to the median range for the District's being compared to. The director of Special Education was given an 8% raise. Now, this year, the Superintendent was given another total compensation raise of 9.7% and the salary for Director of Special Education was raised 5%. Yet, we received a pay decrease. The other 2 raises were for a new position

where someone was promoted under a new job description and for the Director of Maintenance, which still makes below the approx. \$83,000 salary that was for the position in 2009.

This is going to lower moral throughout our classified members. We have given up a lot through concessions and remaining with a lower CAP on our benefits than many other District Employees. Now, once again, for this year, we are saving the District money by paying for our own portion of PERS (Which was previously negotiated in lieu of a rise) which cost every classified employee working 4 hours or more about 2% of their pay as we only had a 5% offset for our 7% that was paid. More members would have even had a bigger reduction in pay if we had not finally received a fair and equitable increase to our medical benefits and finally receive the same medical benefits as other employees once again.

Hearing about other Districts where the entire Districts are getting raises definitely does not help either. A lot of our employees are feeling let down and are not happy at all. I just hope that the bad moral and feelings do not go too deep and end up with a negative impact on our District and our students.

These are the feelings of our members that have contact me, and as I said, soon, many more will be contacting me.

# CONSIDER APPROVING NEW JOB DESCRIPTION FOR LICENSED VOCATIONAL NURSE (LVN) - Davis (14-15 G & O

Component I, II, III, IV, V)

•As part of the ongoing review of job descriptions and the needs of the school sites and the District by both the District and CSEA there exists a need to approve a new job description for the "Licensed Vocational Nurse (LVN)" position which is necessary to meet the very specific health and educational needs of our students, especially in light of new legal requirements regarding controlled medication. The District administration worked with CSEA to bring forward the enclosed job description. The new position will be placed at Range 32 on the Classified Salary Schedule.

Ryan Davis presented new job descriptions for LVNs. The positions are needed due to a new law that pertains to specific health and educational needs to our students. This will also help school office staff with handing out medication throughout the district. These Medical needs are highly needed. # CONSIDER APPROVING RESOLUTION NO. 14/15.5 AUTHORIZING THE LAYOFF AND REDUCTION OF HOURS OF CLASSIFIED EMPLOYEE POSITIONS DUE TO LACK OF

WORK/LACK OF FUNDS - Davis (14-15 G & O Component I, II, III, IV, V)

•Pursuant to Education Code section 45117, the District administration is making a recommendation that would require the Governing Board of the Western Placer Unified School District to layoff or reduce the hours of Classified Employee positions due to lack of work/lack of funds by adopting Resolution No. 14/15.5. This modification is necessitated by lack of work/lack of funds, and related to some of the positions, very low enrollment in a preschool program.

CSEA has been notified of this pending action.

Ryan Davis presented Resolution No. 14/15.5 authorizing layoffs due to lack of funds. Motion by Mr. Long, seconded by Mr. Armitage, and passed by a 4-0 (Ayes: Armitage, Haley, Long, Wyatt, No: None) roll call vote to approve Resolution No. 14/15.5 authorizing the layoff and

reduction of hours of classified employee positions due to lack of work/lack of funds.

REGULATIONS - Steer (14-15 G & O Component I, II, III, IV, V)

# APPROVAL OF MEMORANDUM OF UNDERSTANDING SUPPLEMENT TO JOINT USE AGREEMENT WITH CITY OF LINCOLN FOR PUBLIC ADMINISTRATIVE BUILDING – Steer

(14-15 G & O Component I, II, III, IV, V)

•In February 2006, the District entered into a Joint Use Agreement with the City of Lincoln for the construction and use of the Administrative Building (City Hall/School District Building). The attached supplemental Memorandum of Understanding (MOU) is related to improvements to the server room located on the 4<sup>th</sup> Floor of the Building and encompassed in the space occupied by the District.

Heather Steer reported on the MOU with the City. She shared the situation of the computer server room located on the fourth floor. The reason for the new HVAC component will be to adequately cool the computer infrastructure, along with installation and ownership in accordance with the original Joint Use Agreement. Motion by Mr. Armitage, seconded by Mr. Haley, and passed by a 4-0 (Ayes: Long, Armitage, Haley, Wyatt, No: None) vote to approve the MOU to Joint Use Agreement with the City of Lincoln.

# <u>APPROVE RESOLUTION NO. 14/15.3 LOCAL RESERVE CAP</u> –

Kilpatrick (14-15 G & O Component I, II, III, IV, V)

•On June 20, 2014), the Gov. Brown signed SB 858 (Committee on Budget and Fiscal Review, Chapter 32, Statutes of 2014, which will require school districts to spend their assigned and unassigned account balances down to no more than two to three times the minimum level of the statutory reserve for economic uncertainties (depending on district size) in the fiscal year following the fiscal year in which the State of California makes a payment of any amount to the Public School System Stabilization Account (referred to as the Prop 98 Reserve).

Audrey Kilpatrick presented Resolution No 14/15.3 for the Reserve CAP. Motion by Mr. Haley, seconded by Mr. Armitage, and passed by a 4-0 (**Ayes**: *Haley, Long, Armitage, Wyatt,* **No:** *None*) roll call vote to approve Resolution No. 14/15.3 Local Reserve CAP.
