### <u>APPROVE RESOLUTION NO. 14/15.26 THE EDUCATION</u> <u>PROTECTION ACCOUNT AND SPENDING PLAN FOR 2015-16 -- </u>

Kilpatrick (14-15 G & O Component I, II, III, V, IV)

•Proposition 30, The School and Local Public Safety Protection Act of 2012, approved by the voters on November 6, 2012 temporary increases that states sales tax rate for all taxpayers and the personal income tax rates for upper-income taxpayers. The new revenues generated from Proposition 30 are deposited into a newly created state account called the Education Protection Account (EPA).

Audrey Kilpatrick presented Resolution No. 14/15.26. The Education Protection Account is brought before the board every year. Motion by Mrs. Wyatt, seconded by Mr. Armitage, and passed by a 3-0 (Ayes: Armitage, Wyatt, Haley No: None) roll call vote to approve Resolution No. 14/15.26 The Education Protection Account and Spending Plan for 2015-16.

•The Elementary and Secondary Education Act (ESEA), Title III, Limited English Proficient (LEP) and Immigrant student program statutes require participating local educational agencies (LEAs) to update Goal 2 of their LEA Plan annually, including the budget (ESEA, Title III, Part A, Section 3114).

Kerry Callahan presented the annual updated LEA plan for approval. This needs to be approved by June 30<sup>th</sup> in order to receive monies to serve English Learners. Motion by Mr. Armitage, seconded by Mrs. Wyatt, and passed by a 3-0 (**Ayes**: *Armitage*, *Haley*, *Wyatt* **No**: *None*) vote to approve the LEA Plan, Goal 2 annual update.

### <u>INCREASE PAID LUNCH FEES – 2015-16</u> - Kilpatrick (14-15 G & O Component I, II, III, V, IV)

•With the healthier meal requirements of the Healthy, Hunger-Free Kids Act taking effect in 2010, all school districts were impacted by the higher food costs associated with the changes in food offerings for students. Lunch meal prices were last increase in July 2012 by 10 percent in anticipation of covering the projected increase in food costs.

Audrey Kilpatrick presented the increase for paid lunches. The only increase would be to elementary (TK-5<sup>th</sup>) grades, as well as the Headstart Program. Motion by Mrs. Wyatt, seconded by Mr. Armitage, and passed by a 3-0 (**Ayes**: *Armitage*, *Haley*, *Wyatt* **No**: *None*) vote to approve the 2015-16 increase to paid lunch fees.
