•Basic Aid status is defined as the point at which the property taxes of a district exceed apportionment. At that point, the district receives its proportional share of property taxes. Western Placer Unified School District has been in a basic aid status for several years. However, the District is also sponsor of Horizon Charter School. Under Education Code 47663 this made the District eligible for supplemental funding of 70 cents on each dollar of basic aid funding transferred to the charter school. While this funding was welcomed, staff thought it prudent to look at all aspects of basic aid for the District.
