# 8.2 (D/A) APPROVE RESOLUTION 04/05.31 AUTHORIZING DESIGNATED PERSONNEL SIGN CHILD DEVELOPMENT CONTRACTS – Stewart (04/05 G & O

*Components I-IV)* The attached resolution designates personnel to sign child development contracts between the Western Placer Unified School District and the State of California. This resolution is necessary in order to receive \$21,300 for renovation and repair of the District's preschool facilities.

# 8.3 (D/A) APPROVE RESOLUTION 04/05.33 SCA 8 ALLOWING LOCAL SCHOOL DISTRICTS TO APPROVE A LOCAL PARCEL TAX WITH A 55 PERCENT MAJORITY RATHER THAN THE TWO-THIRDS MAJORITY CURRENTLY REQUIRED – Yohe (04/05 G & O Components V-IV) SCA 8 allows local school districts to approve a local parcel tax with a 55 percent majority rather than the two-thirds majority currently required. By lowering the threshold, more school districts will be able to successfully pass a local parcel tax, which will help them raise the money they need to maintain a quality education. SCA 8 still requires a supermajority in passing a tax.

8.4 (D/A) APPROVE RESOLUTION 04/05.34 AUTHORIZING THE TRANSFER OF THE VALLEY VIEW SCHOOL SITE TO THE THERMALANDS COMMUNITY CENTER – Stewart (04/05 G & O Components V-IV) The attached resolution authorizes the transfer of the Valley View School site to the Thermalands Community Center.
