# APROVE BUDGET ALLOCATION - \$3,250 TOWARD PURCHASE OF LIBRARY BOOK COLLECCTIONS AT TWELVE BRIDGES

LIBRARY - Kilpatrick (13-14 G & O Component I, II, III, IV, V)

•At the last board meeting, the Friends of the Library group requested that the District provide matching funds of \$13,000 towards purchase of library book collections for the Twelve Bridges Library.

Audrey Kilpatrick reported on the funds allocated to Friends of the Library. She reported on funds that have been allocated on LHS for purchasing books, Elementary schools have received funds from donation resources. Motion by Mr. Carras, seconded by Mr. Armitage, and passed by a 5-0 vote to allocate monies to Friends of the Library to purchase library book collections for Twelve Bridges Library.

# RESOLUTION 13/14.10 PURCHASE OF ACREAGE FROM SIERRA JOINT COMMUNITY COLLEGE DISTRICT –

Leaman/Steer (13-14 G & O Component I, II, III, IV, V)

•This item is a Board of Trustees informational update on current Facilities projects and work that has taken place during the summer of 2013, as well as upcoming projects and pending legislation that will affect our District

Mr. Leaman reviewed the Resolution for purchase of acreage from Sierra Joint Community College. The agreement would be a five year purchase deposit, along with the \$10,000 per year. The 26 acres we currently own is not enough, with the additional 32 acres this will provide us with 58 acres. It would make more sense to purchase the additional acreage for a future high school. Motion by Mr. Carras, seconded by Mr. Long, and passed by a roll call vote to approve Resolution 413/14.10, for the purchase of acreage from Sierra Joint Community College District. Roll call vote: Carras, Armitage, Haley, Long, Wyatt

# STAR MOU - Boyle (13-14 G & O Component I, II, III, IV, V)

•The STAR (Science Theater Art Recreation) Program provides fee-based extended day services to students in grades Kindergarten through Grade 5 on several WPUSD campuses.

Mary Boyle presented the STAR MOU for approval. This renewal is for the STAR program which is being operated at five of our schools. STAR is not a district program. Motion by Mr. Haley, seconded by Mr. Armitage, and passed by a 5-0 vote to approve the STAR MOU.

•Draft 2013-14 objectives based on district goals are being presented to the board at this time.

Mr. Leaman presented the first reading of the 2013-14 district goals, and reported they have been reviewed by district administration. He reviewed a few new goals, support TK classes, and Common Core State Standards. He touched on a few; a different type of budget committee; increasing technology; updating Facility Master Plan; school Boundary changes; and will be meeting with wildlife for the Mariner Ranch. He also plans on meeting with the steering committee for local Realtors, continuing to work with the City to have good relations, which include joint agreements; nutrition committee; and suicide prevention committee. Mr. Leaman will bring back 2013-14 Goals and Objectives to the October 15th meeting, for approval.

# 8.6 Information/ INTERDISTRICT AGREEMENTS/RESIDENCY BASED ON EMPLOYMENT REPORT - Leaman (13-14

G&O Component I, II, III, IV, V)

•An interdistrict/Residency Based On Employment (RBOE) report will presented to the Board. In addition to the attached report, it should be noted that there was dramatic decrease in board appeals, but the overall number of interdistrict approvals held at about the same average as past years.

Mr. Leaman reviewed the Interdistrict Agreement/Residency based on employment, 120 were granted on residency, which exceeded the 75% limited by the law. He reviewed reasons for the transfers. There was some discussion as to what grades to stop the child care approval. After some discussion the board decided it should be 5th grade. Employment issue, the decision was to draw a limit, after the 75% go through the appeal process. Reason with transfer, to keep the process the same. There was some discussion of having our county representative come and speak to the board, (Keli Nile). Mr. Leaman will bring back changes on Interdistrict Agreement process.
