Under the guidelines of the growth (New Construction) section of the State School Facility Program, State funding is calculated based on a formula involving unhoused students, number of teaching stations that are being built and other factors. In some cases the program allows for the "Use of Grants." Under the Use of Grants Program, the District can request that new construction grants be transferred from a lower grade configuration to provide the needed grants. This liability is split into two parts; the present value for benefits for existing retirees, and the liability for future costs for present employees who may become eligible for the program when they retire. The board must disclose if they are funding neither, either, or both.
