**Penny Whitworth** shared both daughters have been on the swim team. Our little pool is not keeping up with the population and students. To keep elementary kids here we need to build a new swimming pool, and would like to see a collaboration with the city to build a new pool. McBean is just too small, 60-80 swimmers, it's a no cut sport, and everyone is welcome to join. Six swimming lanes. She asked the board to please consider the investment to our kids in the community, and competitive sports.

**Spenser Westover** shared he is a sophomore on the swim team. We really need a new pool. There are 10 people per lane, no room for improvement. Normally there are 8 lanes required. We need a pool.

Lori Stanley, coach of swim team, shared success and their vision finished average 62 per meet. The boys' swim team earned the first PVL banner for LHS. Had 5 boys go the 2<sup>nd</sup> championship meet in Lodi, and the girls' team came in 3rd place. The vision is to create swimmers, push them beyond their capabilities. Lincoln is becoming a swim town. We have 3 coaches and two stipends. Our athletes swim elsewhere in surrounding communities. Please consider our swim facilities are not equipped as the teams we will be competing against. An avalanche of swimming in this community is coming.

Catharine Johnson, swim team parent shared the reality of a student that has to go to another town to maintain as a swim athlete, and who is ranked on the swim team. There is a lot of money spent to maintain these swimmers, and that money can be spent within the community. Lincoln needs to look at the info structure needs to maintain athletics within the community.
