7. COMMUNICATION FROM THE PUBLIC

Shanti Landon, wife of one of our teachers who spoke in regards to a letter given to her husband. She read the following: Without going into much detail she shared her concerns. Thanked administration and board members for being very attentive and accessible. The letter started a great deal of conversation, brainstorming and research on their part. A lot of teachers were unaware of the current board policy which states instruction concerning controversial issues shall be relevant to the adopted course of study. After a series of conversations with administration, they have come to understand, even answering innocent questions, such as those related to their family farm, were off limits to Mr. Landon as his subject area is Math. As you can imagine that puts Mr. Landon and other teachers in a precarious and burdensome situation. Feels most of you would agree now, our culture now leaves little room for our teachers to have autonomy in their classrooms, and they're expected to teach and act like robots for fear of offending anyone. This is a tragedy for our teachers and our students. After doing some research, she discovered multiple school districts in California have board policies in regards to teachers discussing controversial issues. These board policies allow for some autonomy for teachers to determine how best to address students inquires during class even if there not related to the course work. She believes it's in the best interest of the students and teachers of Western Placer to take a fresh look at the current board policy to see if it's conducive to fostering a true learning environment for students, one that allows for civil discourse in most real way. If we limit teachers' abilities to thoughtfully engage in dialog with their students, we will raise a generation of young adults who have no idea how to engage in productive discussion or to truly critically think because they have never had the chance to practice. If we don't allow teachers to answer student's questions and to respond appropriately, the students will stop asking and that would be devastating. Students can't control at what point during the day their thoughtful questions come up, and it's not fair to say because they're in a Math class at 2:00 p.m. they're going to have to wait for the civics class the next day because their Math Teacher can't answer those. Teenagers are craving authentic relationships with adults who care, and while school should be a safe place for students, for sure they shouldn't be so sterile that they avoid students to think so deeply and sometimes even contemplate ideas that are foreign or somewhat uncomfortable to them. Understands they you can't make a decisions tonight because it's not an item on the agenda, but humbly request that you consider potentially forming a committee of both teachers and staff to take a look at the board policy on controversial issues. Truly believes there is a way to write the policy so teachers have some freedom to dialog with their students even if it's off topic with reasonable parameters. Western Placer is losing incredible teachers who just really want the ability to engage with their students that they are so discourage and so saddened that they just can't remain in teaching if they can no longer truly connect with their kids, hope and pray that you think forward and down the road and consider how to best insure that the students in our schools are getting the very best education possible and where teachers feel their support to use their gifts.
