8.2 Information/ Page 94 - SCHOOL RESOURCE OFFICER - Leaman (18-19 G & O Component I, II, III, IV, V)

• The District has been working with the Lincoln Police Department (LPD) and the Placer County Sheriff Department (PCSD) to provide a School Resource Officer for Lincoln High School due to the expiration of the LPD contract in June of this year.

Mr. Leaman shared the sequence of events on retaining a SRO for our high school. With a series of meetings with both the city, LPD and Placer County Sherriff. LPD is requesting a one year contract allowing them to provide services needed for 5 days a week, along with football games. He reviewed the offerings provide by LPD. Currently LPD is providing an SRO on the LHS campus.

Board comments:

Mr. Armitage shared his concerns are if they are providing coverage for 5 days a week, how many days did we get out of the total amount?

Mr. Carras feels Office Kruger really wants to be the SRO at LHS

Mr. Long gave a yes node to allow LPD to provide the SRO

Prior to approving the contract, the city will need to review the contract, as well as legal and city council. Mr. Leaman shared Officer Krueger is willing to go five (5) days a week.
