6.1 (D) <u>UPDATE ON FINANCIAL POSITION RELATED TO</u> REFUNDING OF CERTIFICATES OF PARTICIPATION –

Ryland (08-09 *G* & *O* Component *IV-V*)

•The District had five series of outstanding issuances of adjustable interest rate certificates of participation ("COPs") issued between 2003 and 2006. Annual debt service payments on these COPs were originally intended to be paid from a combination of CFD special tax proceeds and developer fees. On November 20, 2007, a presentation was given to the Board reviewing each of the outstanding COPs and their scheduled repayment structures, along with the availability and timing of the revenue sources. Potential debt restructuring options were presented to the board for discussion and/or direction. In June of this year, the first 2008 Series A refunding COPs were issued, retiring the 2003 Series A and B. In August of this year, the second 2008 Series b refunding COPs were issued, retiring the 2004 Series.

6.2 (D) 403(b) OMNI SERVICES AGREEMENT AND RETIREMENT PLAN ADOPTION AGREEMENT – Noyes

(08-09 G & O Component IV-V)

•The IRS has adopted a number of changes to 403(b) plans, which will take effect on January 1, 2009. Existing regulations were finalized back in 1964, and the updated regs incorporate the various statutory changes and rulings that have occurred since then. An additional reason for the changes is that the IRS was concerned that in the past, there often was little oversight of workers who took loans from their plans or made hardship withdrawals, sometimes without consideration of limits or penalties. Also, the lack of a plan document minimized the responsibility on the part of the employer to make sure that the plan was clearly spelled out and enforced. The updated regulations will make 403(b) plans look a lot more like the 401(k) plans for workers in private industry.

6.3 (I/D) ZEBRA HOUSING – **Leaman** (08-09 G & O Component IV-V)

•The City of Lincoln is requesting board interest in continuing the Zebra Housing Project. The Board has discussed the project on numerous occasions. Specific financial information will be presented to the Board and made available to the public at the meeting.

6.4 (A) RESOLUTION 08/09.7 APPROVING COMMERCE BANK ACCOUNT – Ryland (08-09 G & O Component IV-V)

•The District utilizes EZSchoolPay.com to allow parents to make online payments to the cafeteria. EZSchoolPay processes transaction and deposits the money into Commerce Bank. Users pay a service fee that is a percentage of the payment amount. Currently, EZSchoolPay is the merchant of record for all of its districts and has one account into which all deposits are made. Due to regulations set forth by the credit card associations, each district that utilizes EZSchoolPay must now set up its own account with Commerce Bank and become its own merchant of record. The attached Resolution #08/09.7, which is commerce Bank's standard certificate of resolution, establishes the District's individual account with the bank. The service fee charged to parents making payments online will change from a percentage to a flat fee of \$2.50 per transaction. This will cover the District expenses associated with providing the service.
