8.1 Information HORIZON CHARTER SCHOOL'S ANNUAL FINANCIAL STATEMENTS AND AUDIT REPORT - Kilpatrick (12-13 G & O

Component I, II, III, IV, V)

• Western Placer Unified School District, as the sponsoring authority for Horizon Charter School, is responsible for fiscal oversight. Accordingly, their annual financial statements and audit report are provided for your review. Gilbert Associates, Inc., prepared the annual audit report of Horizon Charter School for the fiscal year ended June 30, 2012.

Audrey Kilpatrick reported that the Horizon Charter School's audit report has been reviewed, and she will be working closely with HIS to help in areas that need change.

8.2 Discussion

RECEIPT OF THE 2011-12 AUDITED FINANCIAL STATEMENTS

- Kilpatrick (12-13 G & O Component I, II, III, IV, V)
- •The 2011-12 Unaudited Actuals were presented to the Board of Trustees in September. The firm of Crowe Horwath, LLP, has performed the required independent annual audit and submitted our audit report to the State Controller's Office by December 15 as required by law. The auditors will be present at the Board meeting to present highlights of the Audited Financial Statements.

Matt from Crowe Horwath reported on the annual 2011-12 audit report and the process used.

8.3 Information EXPRESS BUS RIDERSHIP UPDATE - Kilpatrick (12-13 G & O Component I, II, III, IV, V)

•At the start of the 2012-13 school year the District started an Express Bus that transported students in the Lincoln Crossings and Twelve Bridges areas to Lincoln High School. The Board had requested an update on ridership for this special route. Haley is in favor of keeping the bus in place, as well as Mr. Long. Mr. Leaman recommended we bring this back in June and review again.

Audrey Kilpatrick reported on the cost of the Express bus Ridership, she is currently working with Mark Derossett on advertising to increase ridership for this special route, and will work with the LHS to let students know the bus is available.

8.4 Information 2013-14 BUDGET REDUCTIONS - Leaman/Kilpatrick (12-13 G & O Component I, II, III, IV, V)

• The district is currently deficit spending and faced with budget reductions. The Board has directed staff to achieve a balanced budget by the 2013-14 budget year.

Mr. Leaman reviewed the spreadsheet explaining the headings and their meaning, and explained his process on how the district could least impact staff. He reviewed the items that need to be negotiated with the different groups. As we need to obtain a positive reserve of 3%. He expressed after today's meeting regarding the governor's proposed budget, we may be better off than we thought. There are many unknowns at this time. The district hopes to have more information from State Finance within two weeks.

Mike Agrippino shared its good to hear good news from Scott regarding the budget, will continue to monitor the state budget.

8.5 Action

COMPREHENSIVE SAFE SCHOOL PLANS - Boyle (12-13 G & O Component I, II, III, IV, V)

•School safety is paramount in Western Placer Unified School District. Each of our eleven school sites and the district office practice safety on a daily basis by implementing processes and procedures to safeguard our students and staff as

well as scheduling regular safety drills to practice responses to potential fire, lock-down and/or shelter-in-place situations. The District communicates with local law enforcement to determine and communicate best safety practices at our sites.

Mrs. Boyle reported on the Comprehensive safe school plans, and talked about closed campuses, and has worked with LPD on safety during the day, and the need of access grounds. Drills are practiced annually at each site. Some being shelter in place, fire, and lockdown drills. The district is in the process of changing radios that will allow use access to all sites. Motion by Mr. Haley, seconded by Mr. Armitage, and passed by a 4-0 vote to approve Comprehensive Safe School Plans.

8.6 Information ATTENDANCE UPDATE - Boyle (12-13 G & O Component I, II, III, IV, V) •Two years ago, the District Attendance Work Group (DAWG) was formed to study student attendance patterns and to formulate positive programs to encourage improved student attendance. Research (and common sense!) shows that there is a high correlation between regular student attendance and student achievement in school.

> Mary Boyle showed a power point on Attendance and the DAWG Program, (District Attendance Work Group) which is made up of administrators, certificated, classified members across the district. The following were reviewed:

- Studies were done on ~ Student Costs, Personnel Costs, Revenues Costs, and Societal Costs
- Definitions Satisfactory Attendance, Chronic Absence, WPUSD Attendance
- Student/Societal Costs ~ Chronic K Absence, Poor 6th Grade Attendance, 9th Grade Attendance
- Personnel/Revenue Costs
- DAWG Recommendations ~ Inform parents, Implement "SAM", Implement SARB, Support Families, & Expand SARB Hearings
- **RESULTS:**
 - ~ Revenue Gains 2011/12 improvement of 5% attendance yielded increase of approximately \$225,000 in revenue.
 - ~ Revenue Gains 2012/13 current projected ADDITIONAL improvement of 5% attendance is expected to yield an additional \$225,000 in revenues.

Michael Doherty, PHS Principal/Hearing Officer spoke about the SAM (School Attendance Mediation) Program and also the SARB process. The SAM meetings are held once a month at Phoenix High School, which include administration, parents, students and Judge Nichols.

8.7 Information/ ADJUSTMENT OF MIDDLE SCHOOL ATTENDANCE BOUNDARIES - Steer (12-13 G & O Component I, II, III, IV, V) Discussion

•In late 2009 the Board of Trustees began a discussion around the necessity to restructure the middle school attendance boundaries lines within Western Placer Unified School District. At the time we anticipated that the 6th – 8th grade population at Twelve Bridges Middle School would increase to the point of capacity, and it would become necessary to adjust the attendance between Twelve Bridges Middle and Glen Edwards Middle School. Because the capacity was not yet extended, and due to some concerns about shifting attendance boundaries, the discussion was tabled.

Heather Steer touched on middle school attendance boundaries, and past history of boundary changes. She reviewed the statistics in 2009 as well as current statistics. TBMS is almost at capacity and GEMS is at capacity. She presented boundary maps indicated numbers of students in particular areas. Boundary adjustments would give GEMS approximately 214 additional students over the next three school years. We currently have two bussing routs for students from CCC to TBMS. If no changes are made TBMS will be over capacity by next year. Another option is adjusting other boundaries, or adjusting Carlin C. Coppin to attend GEMS.
