# 9.2 Action Page 212 - EDUCATOR EFFECTIVENESS BLOCK GRANT PLAN - Pickett (21-22 G & O Component I, II, III, IV, V)

Scott Pickett stated recently, Western Placer Unified School District was allocated restricted, one –time Educator Effectiveness Funds (EFF) by the California Department of Education. These EEF Funds, in coordination with federal Tittle II funds, are intended to support professional learning for certificated teachers, administrators, paraprofessional educators, and other certificated staff, EFF funds must be expended by June 30, 2026.

As a requirement to receive these funds, WPUSD must prepare a local written plan. Per the statute, the that plan was publicly presented to the board of trustees on December 7, 2021 board meeting. The local written plan must be adopted no later than December 30, 2021.

Criste Freymond had a question regarding information on page 9 Major Expenditure Changes it shows Twelve Bridges High School site discretionary allocation funds of \$60,000, what is that for? Mrs. Kilpatrick stated that each school site received discretionary funds in expenditures operating budget at the school site that's based on their projected enrollment in the beginning of the year times a certain dollar amount depending on if they are elementary, middle or high school. They set them up with the budget in the beginning of the year, that school increased their enrollment so in October, we look at every school and if there is enrollment increases, we add discretionary funds, we increase their operating budget. Twelve Bridges High increased their enrollment, so they gave them more money for their school.

## 11.2 BOARD MEMBER REPORTS/COMMENTS

Criste Freymond stated she wanted to let everyone know that she met with the Lincoln High School Wrestling Coach Mark Fuller regarding a fundraiser on January 8th. She wanted to thank everyone for coming and expressing themselves. Their comments do matter, regardless of which side they are on. Everybody's comments matter and she appreciates them coming for all of this. She wanted to say that she hopes this new year brings us much needed change in our country. She wished everyone a very Merry Christmas and to enjoy their time with their families. April Nitsos stated she wanted to commend the seven boys at the meeting for their great behavior and sitting there for three hours. She wanted to thank everybody for the comparison between the meeting two weeks ago and this time, it was wonderful. In her opinion, someone stated this is not a mandate, she believes that one of the reasons is that he wanted to divide us as well and she is so glad to see that we were not divided tonight. Look at what we can accomplish when we are not divided. We are, "united we stand, divided we fall" and she does not want to fall. She stated that they all know where she stands, and she hopes that they can all keep this momentum going of working together. She knows that when we work together and Kerry puts together her advisory committee, she knows we can do great things. She reached out to the new mayor Holly Andreatta to ask the city to consider declaring this a sanctuary city against mask and vaccine mandates. They mayor is going to talk to her board. Met with Kerry Callahan and Marjorie Proffitt and had some great discussions about solutions. She also reached out to Chris Baldwin who could not make it tonight to talk about solutions. She also spoke to Jonathan Zacherson from Let Them Breathe, to get some ideas from him. She spoke to a private attorney to find out what her liability she would have as a board member for going against mandates. She spoke to Tiffany Saathoff from Rockin Unified School Board, she is the one that spear headed their resolution letter. She is meeting with Shanti Landon to discuss the 2022 primary election and her run for Placer County Supervisor. She will be talking to her about her ideas regarding these mandates. She wished everyone a Merry Christmas and a Happy New Year and remember the reason for the season.

Kris Wyatt stated she wanted to thank Jennifer Hladun, Principal of Lincoln High School for the letter she sent out to families about the lockdown and regarding where she can approve, what happened and to stifle the rumors. Thank you also to our police officers. Tomorrow night, a former student of ours, Abby Faingold who has been playing soccer internationally will be speaking to anyone who want to come listen to her. She is a goalie, she has traveled to many place to play soccer.

Bring your children so that they can hear what someone can do with their life when they have their mind set. She stated that one of the reasons she wears her mask is because she is around many senior citizens. At her Rotary meeting last week, they were divided between those that want to wear mask and those that do not. Those that did want to wear mask think that they are asking the rest of them do it because it is a mandate when we are indoors. She has lost friends due to COVID and it is very sad and whether you believe it's real or not, to have someone die because of COVID, it's horrible. Just out of common courtesy when others don't want to be around when you are not wearing a mask, she just wishes that they would be okay with that. Happy Holidays, and Happy Chanukah and Kwanza

**Jason Price** stated he appreciates the thoughts. He stated he knows that it doesn't seem like they are paying attention, but they are. He is happy with April's idea of putting together a committee that includes stakeholders. Some of the things you are seeing, they are kind of political gestures. You can kind of see through some of the smoke, like March as a date but the thing is supposed to expire in March. He enjoys the ideas of trying to find way around. He stated that to him defiance is hard, there are a lot of downstream problems to defying a law. He has tried to articulate some of those and he knows they are not popular. Common sense doesn't resonate well, like "Beta Male', which by the way was mean. He appreciates that the tone was better. He asked a favor; it shouldn't be that part of the community that disagrees isn't given space to talk for three minutes without being shouted at. He feels they have failed as a board to create a space where someone can come in and just say something that the entire room doesn't agree with. He thinks it sets a bad example for young people to feel like they can just shout over somebody else because they disagree with them. That is part of what has made America, that we can stand on both sides of an argument, not make it personal. It shouldn't be personal. None of us have disagreed since the start of this. We have pushed, and he knows it's not fast enough, but they are pushing to try and make sure that they are seen. To make sure that their voice makes its. It is very difficult for him to feel good about these meetings when he can't promise someone that they will given three minutes to speak without someone yelling at them. He asked that to be communicated because he does not like the tone of a meeting that does not welcome both sides of the argument. Both sides should have their three minutes. He also wanted to say to Principal Hladun, He has participated in active shooter drills. He has responded to them as a first responder. These events are terrifying. He can't imagine what that feeling is like for someone who works with these kids every single day and knows the staff that are now in harm's way. The swift actions, decisive, thorough and the interactions between us and law enforcement was amazing. Mrs. Hladun sent an email that stated, "here's some ways I can improve." He was very impressed with the way it was handled and her wanting to do it better. It sends a wonderful message of what it is like to be a leader.

**Damian Armitage** thanked Kris Wyatt for the past year of being president. It is not a very easy job. He wanted everyone to know that he personally agrees with 99 percent of what is being said here. He wanted to let them know that some of the things are privileged conversations that they have and they cannot talk about them. There are positive things happening and they are working for them. He understands and supports someone's right to choose. Someone mentioned heart problems. His nephew died a few years ago at 19 years old due to heart issues, he understands

those issues. He had the opportunity to meet with the Unity Projects and they gave a lot of good information and offered legal support. He wanted to thank the board for having the confidence in him to go the next twelve months. Merry Christmas
