### 4. SPECIAL ORDER OF BUSINESS - Terry Ryland, TRR School Business Consulting will Review Horizon Charter School & Partnership for Student-Centered Learning Charter School

In December 2012, Horizon Charter School (HCS) along with its related Partnership for Student-Centered Learning Charter School (PSCL) was encountering public concerns, negative media coverage and administrative angst regarding certain programs and agreements related to the recently chartered PSCL charter school. In the spirit of transparency and a desire to determine the extent of any peculiarities or improprieties, TRR School Business Consulting was contracted by Horizon to provide an in-depth review of the lease and facilities agreements, the financial status of the charter schools, internal controls, processes and procedures and the overall fiscal health of the operations. Terri Ryland will be presenting the results and recommendations as a result of the review.

#### 8.3 CONSIDERATION OF ACQUISITION OF PROPERTY

Education Code section 17211 requires that a public hearing be held prior to commencing the acquisition of real property for a new school site or an addition to an existing school site. The governing board of a school district shall evaluate the property at a public hearing using the site selection standards established by the State Department of Education pursuant to subdivision (b) of Section 17251.

This hearing is to evaluate the possible acquisition of 38.6 acres of property from Sierra Joint Community College District adjacent to our current Twelve Bridges High School site. In conjunction with School Site Solutions, Inc., staff has done the following to evaluate the acreage in question:

- Geohazards study which evaluated potential hazards on or adjacent to the property
- Completed a Pipeline Risk Safety Study, due to a natural gas pipeline being located within Twelve Bridges Drive. No safety hazards exist.
- Completed a new site plan showing how the entire property could potentially accommodate a comprehensive high school
- Completed a full legal description of the property
- Conducted a site tour with a Field Representative from California Department of Education
- Completed a Contingent Site Approval package for California Department of Education's review, in which all findings comply with all of the California Department of Education's standards.

A full site approval from California Department of Education will be pursued should we acquire the property, and a new school is being designed. Also at that time a new Environmental Impact Report would need to be completed.

#### 9.2 Action <u>POSITION DESCRIPTION: TEACHER ON SPECIAL</u> <u>ASSIGNMENT- PEER COACH</u> – Boyle/Davis (12-13 G & O Component I, III, IV, V)

•Last year, Western Placer Teachers Association (WPTA) and the District entered into a one-year MOU to pool swept Tier III categorical funds from Peer Assistance and Review (PAR) and Professional Development Block Grant resources in order to create two new positions –

• Teacher on Special Assignment – Peer Coach Elementary

• Teacher on Special Assignment – Peer Coach Secondary

These two new positions allowed the District to provide professional development support to its teachers as we targeted improved student learning, began to implement Common Core State Standards (CCSS), and prepared for Smarter Balanced Assessment Consortium (SBAC) testing. The positions were filled by two WPUSD teachers and the program has been very successful.

#### 9.3 Discussion/ Action RATIFICATION OF MEMORANDUM OF UNDERSTANDING WITH CSEA REGARDING BUDGET REDUCTIONS INCLUDING FURLOUGH DAYS AND OTHER ITEMS – Davis (12-13 G & O Component III, IV, V)

•The Western Placer Unified School District and the California School Employees Association Chapter #741 have signed a Memorandum of Understanding regarding furlough days, salary, and other items for the 2013/2014 school year. This MOU will greatly assist the District with achieving its required budget reductions for the 2013-2014 school year while saving positions and programs. This MOU is going to a ratification vote of the Unit Membership on Wednesday, April 10, 2013.
