7.1 (D/A) APPROVAL OF THE CLASSIFIED EMPLOYEE'S RECLASSIFICATION STUDY - Noyes (03-04 G & O Component IV-V)

•The Western Placer Unified School district has not reviewed its classified employee positions in over ten years.
