2. **COMMUNICATION FROM THE PUBLIC**

Emily McKinnon shared her journey through Western Placer as a students, it is with great reluctance and sadness that I resign from Glen Edwards Middle school effective the end of this year. I love this community, and have wanted nothing more than to come back and teach in this district after college. It's been a dream of mine for a long time to become a teacher and to be a part of the community where I grew up. Regardless of what happens tonight, I hope I can return to this district, this is where my heart is.

Debbie Freid shared she met Emily when she was 10 years old. I don't work with her personally, but I know her resignation was not by choice, and the board needs to know. My observations of her are she conducts herself as a seasoned professional, doesn't act like a brand new teacher, and she has so much energy in the positive way. She is an asset to our campus, asset to WPUSD. She has ideas that we dream about. We learned to do a whole system of testing and assessment because of Emily. She shared on a personal standpoint as her daughter has subbed in Emily's class. She is

organized and prepared, and the kids have a great connection with her. She is the kind of employee that we want at WPUSD. She is our future and want the board to know, we need more Emily McKinnon in our district.

Lori Reitman honored to be a part of this district, and have worked with so many teachers for the past 25 years. I have had the opportunity to work with Emily this year in Sixth grade, she was one of my students. She has an amazing rapport with children, parents, teachers and colleagues. She has ideas that are unbelievable. The students love her and respect her. We could go on for hours and hours. I'm very saddened by the decision that was made. I hope something changes and I hope your back with us or somewhere in the district. Students will miss you and we will miss you. Thank you for what you have done for Glen Edwards Middle School

Mary MacQueen, shared she works at Lincoln High School, I would like to read a letter from Emily's Teacher Induction Coach, Amy Perkins. *"I have had the pleasure of working with Emily McKinnon's teacher induction coach for the 2017-18 school year. As a coach, one of my roles is to observe Emily teaching, over the past 17 years I've coached hundreds of new teachers in dozens of schools throughout Placer County. Emily is exemplary. She's is a total natural. Her classroom, management is spot on. It's obvious that the students respect and admire her. Never once, in the many hours that I spend in her class, did I witness a single student misbehaving or off task. Emily manages to utilize every single second of teacher teaching period. Her transitions are seamless. In under one minute, students enter her classroom, get what they need, and are focused on her, ready for instruction. Emily sets these kids up for success by laying out clear expectations and her students raise to meet them. In some of the data that we review together, six months into this year, she had students improve their reading scores by up to three entire grade levels. The growth those kids are making is proof of how incredible she is. She loves what she does, and she loves her students. I think she's the only 6th-grade teacher I've worked with that celebrates each child on their birthday. Not only celebrate them, but she tells all of her classes that if they see the birthday student around campus to be sure to acknowledge and celebrate them as well. Probably the highest compliment I could give her is not from my coaching perspective but for that as a parent. I could only hope that my own children's teachers care about them as much as Emily cares about her students. Without hesitation, I would want her to be my own children's teacher. Emily is truly a fantastic asset to her sixth-grade GEMS team. Sincerely Amy Perkins, PCOE, Teacher Induction Coach."* Mary MacQueen also shared she was Emily's high school teacher. Someone asked how could I speak on Emily's behalf, since I have never seen her teach? I said it's easy. Emily is a person of character, she is hard working, always gave 100% always did her best, in leadership and yearbook she encouraged people, she helped student along the way, never had to worry about her job not being done, and I know she would help she other as well, I saw that in her as a high school student. Emily was always on task and got the job done, and always gave it 100%, she is defiantly an asset to our school.

Marilou Edwards – spoke on behalf of Emily, she was also one of her students. She wasn't just one of my students, she was my student, I have students who work so hard, they're the ones who stay late at, make sure things were done, she was an adult, and had the expectations that I have. I am really sadden that were going to lose someone like her. She will accomplish many projects as a teacher, she helped with the tutoring program. If you're in this district and work hard, you're going to be able to accomplish things in this district. The young teachers are our future, we have amazing teachers. She loves this district. I'm afraid she will be snatched from another district. Not many people will spend their summers trying to raise money for funding for their classroom, she is already thinking of these things.

Adian Zinzun shared he is in 8th grade student at Glen Edwards Middle School. This evening I would like to let you all know what a great teacher Ms. McKinnon for most of my life and I was so happy when I found out that she would be teaching at Glen Edwards. Before being hired permanently, Ms. McKinnon was a long term substitute teacher at our school and I was lucky enough to have her during my 7th grade year. As a past student of Glen Edwards herself, Ms. McKinnon is so passionate and proud to teach at the school she attended. Ms. McKinnon has

brought school spirit to our campus by encouraging students to participate in dress up days and always dressing up herself. I always see Ms. McKinnon at school events cheering us on. Whether it's attending after school sporting events or tutoring students, it is very clear that she is a dedicated teacher that always puts us students first. Ms. McKinnon is not only a great teacher she is caring and realizes that each student is special in their own way. Ms. McKinnon goes out of her way to get to know each and every one of her students as individuals. I truly hope that our school district realizes the positive impact that Ms. McKinnon has had on many student's lives in the short time she has been here. Ms. McKinnon is our district's biggest fan and we cannot afford to let such a great teacher leave Western Placer Unified School District.

Trinity Cooney she shared she met Emily while working at Morgan Creek, she was a part of the banquet dept., she was her direct supervisor. I quickly saw her drive and determination, and struck me, because she was such young person. But she knew where she was going, and she knew the road to get there. As a student, athletic, coach in this community and an employee, Emily was able to balance it all and thrive. I came to rely on Emily as my top server handling the bride and groom, which requires a forward thinker and a can do attitude. Emily began babysitting for me, I began to rely heavily on her child development skills, and nothing has changed 8 year later. We wanted to buy a home, Emily encouraged our family to purchase a home in Lincoln. My hesitation was the schools, and their rating, and Emily and I sat down and had a conversation about the schools, teachers and the community. She told me it doesn't matter what a school looks like on the outside, but about what's going on inside the school, and how dedicated the teachers are here. She told us to give it a chance and we did. We purchased a home here and we're raising a family because of her. Going from elementary, middle school and high school to giving her commencement speech at her college graduation. Emily returned here to teach and to give back to her home town and her community.

Dawn McKinney teaches at TBMS, 6th Lang. Arts, I was luck, and blessed to be put into a situation where I got to work with Emily every Monday for her professional learning community. She is so creative, so enthusiastic and pays attention to detail, she knows teaching strategies, and thank goodness. She is really good at technology, she saved our group a lot. This is my 18th year and I took on one of the biggest projects that I have ever done this year, there are only four in our group, we're writing curriculum for Language Arts, supporting ELD Standards, Common Core standards, and Emily is a huge contributor to the group, she has a fresh approach, great ideas, very willing to work as part of a team. On a personal note I've grown very fond of Emily, I love working with her, I wish all my colleagues were that positive to work with.

Jason Noonan teaches at GEMS. I've known Emily for 15 years, I know her as a student, T.A., my kid's babysitter, and most recently as a colleague at GEMS. It's not every day that you see teachers of the caliber join this staff. I'm standing here because she is the type of teacher you want working at your school, she is passionate, someone who is dedicated, and someone who is always going to put students first. Last year when I heard she was hired, I was ecstatic, someone who I knew who could make an immediate impact on students, I knew we gained a qualified, knowledgeable, enthusiastic teacher, but we also gained someone who will go above and beyond to get involved in the school and make a difference in her students' lives. She has a natural ability to build connections with every student, and is literally one of the most organized people that I know. Walking into her room, you would never think this is a year one teacher. I remember my first few years teaching at Lincoln High School. A veteran teacher approached me and said my enthusiasm was inspiring to them, I didn't know what they meant at the time, I understand it was a complement. Emily has become that teacher for me, she is that teacher that is in her room setting up June when school starts in August. She's that teacher attending sporting events, because she wants her students to know she cares. She is the teacher that you find in her classroom at dawn, 6:00 a.m. grading her students essays. She's that teacher that knows all of her students names the first week of school. So what I'm trying to say she is that teacher that we can't let go.

Kelly Ransford teaches at GEMS, next door to Emily. I have had the pleasure of working and collaborating with Emily, and I'm honored to call her a colleague of mine. Emily has continued to

amaze me with her significant contributions and collaborative grade level meetings. Her actions and behavior are not of what I would consider a new teacher to be. She has on multiple occasion's exemplified outstanding teaching ethics and professionalism. Listening to her speak of her practices in the classroom is similar to what I would expect of a veteran teacher to convey. She has good rapport with her students and colleagues. She has used great strategies in the classroom working with English Language Learners, and has worked closely with our TOSA support staff to ensure our EL students receive the greatest support possible. Emily has worked very hard this year and has put a lot of time in her job as a teacher. She has also done extra-curricular things, and she is involved in sports, she started a hair club for girls, she have given me a real hope in the future of our teachers, and the teaching profession by putting a tremendous amount of effort into her classes and her students. She believes in her students, and their ability, she loves them. She loves the community and the school. She knows families of her students. It's sad when you see a teacher so new and so mature in her profession and she has such great motivation it horrible to see it be hindered and that she can't continue with us. I ask that you reconsider Emily and make a decision that will reflect our district's hope in our children's future.

Eileen Binning 6th grade teacher at TBMS, when I heard about Emily's situation, I was both shocked and very disappointed. I can say I agree with everything everyone has shared so far. I met her in 2003 when I was the art-docent in her class. This year I got to be on the professional learning committee with her and she has been an integral part of that. She always has a positive attitude. She came in and took on the task with enthusiasm, it's pretty overwhelming task writing curriculum. She was pretty right on board ready to go. Everything people have shared here tonight, so there is not much to add. She is very reflective on what is happening in her classroom and what's been happening with her students, what's the next step, and taking it to the next level. I would ask that you reconsider her resignation.
